
**Re: Envirosafe Services of Ohio, Inc.

Dear Mr. Terpinski:

In accordance with Condition E.13 of its Ohio Hazardous Waste Facility Installation and Operation Permit (the "Permit"), Envirosafe Services of Ohio, Inc. ("ESOI") hereby submits this progress report to the Ohio Environmental Protection Agency ("Ohio EPA") for the period beginning September 1, 2025 and ending September 30, 2025.

Corrective Measures Implementation ("CMI"):

Project Activities:



During this reporting period, CMI activities included the following:

1. Leachate system maintenance included:
 - Inspection of piezometers and recovery wells on SWMUs 5, 6, and 7:
 - Recorded liquid level at each location with a control panel;
 - Verified functionality of all pumps without a control panel;
 - PZ-13: Pump stuck in well and inoperable – assessing replacement;
 - DPW-22: Transducer unresponsive – replacement has been scheduled;
 - NRP-26: Above hi point – pump starter scheduled for replacement;
 - NRP-29: Above hi point – pump starter scheduled for replacement;
 - NRP-31: Transducer was reading incorrectly – repaired loose wire on transducer and verified working;
 - NRP-30: Displayed negative level – tightened loose wire inside control panel and began reading correctly;
 - NRP-34 Replaced dim control panel display;
 - SWMU 6 Compressor: Compressor over-pressurizing – replaced faulty solenoid – compressor continues over-pressurizing – will evaluate pressure switch next – emptied condensation bucket – compressor and attic fan observed to be functioning as designed;
 - SWMU 7: Reset main breakers and individual well breakers – no change;
2. NAPL Recovery System – NAPL levels observed as skim to not present, absorbent sock at well T-205(5) replaced, others observed with available capacity.

Summary of All CMI-Related Contacts with the Public:

ESOI has not had any related contacts with the public during this reporting period.

Summary of Potential or Encountered Problems and Rectification Actions:

There is nothing to report in association with this topic for this reporting period.

Projected Work:

During the next reporting period it is anticipated that the following activities will occur:

1. PZ-13 – Replacement of damaged riser, discharge line and pump if needed – active as piezometer;
2. DPW-22 – Replacement of transducer – not urgent or impacting TLL;
3. NRP-26 & NRP-29 – Replacement of pump starter;
4. SWMU-6 compressor – Repair or replace pressure switch;
5. SWMU-7 – Evaluate electrical issues; and
6. Continued operation and maintenance of the leachate extraction systems on SWMUs 5, 6, and 7.
